ACCOUNTANT'S COMPILATION REPORT


Incorporation of the foundation

NOTES TO THE FINANCIAL STATEMENTS GENERAL

The reporting year covers the period July 1, 2024 to June 30, 2025.

Activities

The objectives of the Foundation are:

To highlight extremely high-quality journalism within member countries of the Council of Europe, to promote and support organizations in these countries in providing good journalism, and to advance collaboration between organizations in member countries of the Council of Europe.

Registered office, legal form and registration number at the chamber of commerce

The registered and actual address of Stichting European Press Prize is Kleine-Gartmanplantsoen 10 in Amsterdam.

GENERAL ACCOUNTING PRINCIPLES FOR THE PREPARATION OF THE ANNUAL ACCOUNTS

We have compiled the financial statements using the accounting policies as included in generally accepted principles for financial reporting in the Netherlands.

The annual accounts have been prepared based on the historical cost and the Accounting Principles of RJK C1 "kleine organisaties zonder winststreven" of the Dutch standards on reporting. Valuation of assets and liabilities and determination of the result take place under the historical cost convention.

The formation of by the Board designated intended reserves take place at the expense of the Statement of Income and Expenses Account. The intended reserves will be separately presented within the foundation capital.

Income and expenses are allocated to the year to which they relate. Profits are only included insofar as they have been realized on the balance sheet date. Liabilities and possible losses that originate before the end of the reporting year are taken into account if they have become known before the preparation of the annual accounts.

ACCOUNTING PRINCIPLES APPLIED TO THE VALUATION OF ASSETS AND LIABILITIES

Receivables, prepayments and accrued income

Receivables, prepayments and accrued income are valued at nominal value.

Cash

Cash and cash equivalents are valued at nominal value.

Current liabilities

On initial recognition current liabilities are recognised at fair value. After initial recognition current liabilities are recognised at the amortised cost price, being the amount received taking into account premiums or discounts and minus transaction costs. This is usually the nominal value.

ACCOUNTING PRINCIPLES FOR THE DETERMINATION OF THE RESULT

General

The result is defined as the difference between the income from services performed on the one hand and on the other hand the costs and expenses for that year, based on historical costs.

General

Revenue means donations and gifts received.

Expenses general

Costs are determined on a historical basis and are attributed to the reporting year to which they relate.

Taxes

The foundation does not aim to gain profits. The foundation is exempted from Corporation Income Tax and VAT.

We have received € 7,500 in earmarked funding from ZEIT-Stiftung Bucerius for organising a conference at Publix, Berlin. The total costs made for the conference add up to € 8,376. The difference of € 876 came from our intended reserves.

We have received € 36,374 in earmarked funding from Studio Europa Maastricht, Gemeente Den Haag and Beeld & Geluid Den Haag for organising the European Cartoon Award. This is the last season that we are the main organisers for the European Cartoon Award. From next season onwards, Studio Europa Maastricht has taken over the coordination of the European Cartoon Award and all finances will be handled by them.

Staff

During 2024/2025, two employees were employed for 0.84 fte each for the entire duration of our 2024/2025 season and one employee was employed for 0.63 fte from July until October. The total personnel costs for the financial year amounted to \in 142,216. As per season 2024/2025 staff costs are no longer classified under miscellaneous organisational expenses, but separately as staff costs. The reason for this is to clearly separate external organisational expenses from staff costs. The total personnel costs can be broken down across the following activities, based on the respective share of staff hours per activity:
